PANEL INSTRUCTIONS:

Conference participants are expected to have <u>read most of the papers</u> and to be ready to participate in the discussions with constructive feedback. Preparation is key!

In addition, all participants will have assigned tasks as chairs, discussants and question-providers. Discussants will provide fuller feedback and questions/comments, whereas question-providers prepare 1-2 questions/comments for each paper.

2-paper panels (80 min): Max 10 min presentation of each paper (by authors), followed by 10-15 min for the discussant + 5 min for each author to respond. 25-30 min for Q&A, starting with question-providers. End with 5 min for each presenter to wrap up.

3-paper panels (120 min): Max 10 min presentation of each paper (by authors), followed by 15-25 min for the discussant + 5 min for each author to respond. 35-40 min for Q&A, starting with question-providers. End with 5 min for each presenter to wrap up.
