**Edmé Domínguez Reyes** is Associate Professor in Peace and Development Studies at the School of Global Studies, Gothenburg University, Sweden. Her field is International Relations with a Ph.D. in Political Science with a specialisation on the Soviet Union-Eastern Europe, from the Institut d'Études Politiques of Paris. Her first area of research and publications was on Soviet foreign policy towards Latin America. Since the beginning of the 1990s her works and publications have focused on Regionalism in the case of NAFTA and Mexico, and on gender issues related to citizenship, labour organising, transnational activism, gender consequences of free trade agreements, and international political economy. Her research on these issues has concentrated on the cases of Mexico, El Salvador and Bolivia.
