## Interaction with society and government

I have assignments for ISF (The Swedish Social Insurance Inspectorate) as PI in the evaluation of occupational injury insurance in an interdisciplinary group at GU, including sociologists, insurance physicians, and lawyers (also mentioned above).

I have previously participated in two government assignments dealing with gender equality issues. One of the government assignments in gender equality was conducted within the framework of Jämi, who was mandated to work on gender mainstreaming in central administration in Sweden. My work involved designing and implementing two studies, one quantitative and one qualitative, the writing of two reports, and the presentation of the results. The quantitative research was presented repeatedly, in Almedalen, in a special hearing at the Social Ministry, and at conferences organized by Jämi, a two-year Government assignment to investigate gender equality in central authorities. I was hired as a gender expert and investigator for six months full-time. Two reports were published from this assignment (**Stensöta Olofsdotter, Helena 2009c; 2010d** mentioned in 5.2.)

The other government assignment in gender equality was part of the government program, "Delegation for Gender Equality In Higher Education," where I received research funding together with Johanna Andersson to conduct a study of recruitment patterns at Chalmers. We made a total selection of recruitment cases over 2.5 years and assessed the bibliometric level of each applicant to search for gender differences. We found no gender differences in this regard. We also examined whether the gender of the evaluator mattered and concluded that female evaluators ranked female applicants higher. However, this could also be an effect of shared research interest. This report was also presented on several occasions (see below 8.2.1). Two reports were published from this assignment (Stensöta Olofsdotter, Helena 2010a; 2011, mentioned in 5.2.)
