I have developed and acted as course director for 9 different courses on bachelors and masters' level, including one full academic semester with four different courses.

I have acted as an **expert consultant** to the Raul Wallenberg Institute, LU, on law and gender pedagogy, and I conduct **professional trainings** for public authorities and private corporations on law and gender, including an online global course for law teachers. I have developed professional trainings in AI and Law in collaboration with AI Sweden and the Region Västra Götaland, (VGR) Sweden for health care personnel. Within the GU External Executive Education, Stockholm University Executive Education, and Uppsala Executive Education, I have developed and taught modules on AI and Law for CEO:s in both private and public sectors, as well as specific courses for commercial clients. I have also developed and taught several pedagogical modules on AI and Law for High School teachers since 2024. I recurrently deliver educational and inspirational talks on AI and Law for professionals in a number of Swedish professional settings and contexts outside of academia.

In 2021 I developed two Law and AI modules for the first ever **MOOC** hosted by GU. I am currently co-developing the 'AI in Theory and Practice' interdisciplinary master program and a summer school in Higher Education with the Wallenberg AI, Autonomous Systems and Software Program – Education (WASP-ED).
